<p>If a child has one or more symptoms, they must be sent home immediately to follow public health advice and self-isolate, including household members unless they have been fully vaccinated or are under 18 years and 6 months old. They should call 119 to arrange to have a PCR test immediately. Request that test results are shared as soon as available. If the test result is positive and it is a confirmed case, we will contain the outbreak in line with our outbreak management plan with household members including siblings self isolating for the full 7 days from the onset of the symptoms or the positive test result, following DfE and local PHE health protection team guidance as well as inform our Trust, SMC and LA. NHS Test and Trace will work with positive cases to identify close contacts with support from the school where needed.</p> <p>Whilst waiting for a pupil to be collected, an available member of staff will supervise them in our COVID-19 area (Cara or Rainbow room)</p> <p>Staff must immediately go home to self isolate and follow public health advice if displaying one or more symptoms, booking a PCR tested immediately. Household members will need to self isolate too unless they have been fully vaccinated or are under 18 years and 6 months old. Area and items used by staff member to be thoroughly cleaned. If the test result is positive and it is a confirmed case, we will contain the outbreak in line with our contingency plan</p> <p>If a pupil or staff PCR test result is negative, they may return to school if no longer symptomatic, 24 hours fever free and as soon as they are fit and well enough to do so.</p>

<p>All rooms should have at least windows open slightly and door propped open (except fire doors) to balance good ventilation and maintaining a comfortable temperature. When the school hall is vacated and the classrooms vacated for break, windows and doors should be fully opened to allow a surge of fresh air to enter the room so the air within is completely refreshed. If a door cannot be propped open when in use, door handles should be anti-bac cleaned frequently, in line with cleaning schedule.</p> <p>To balance the need for increased ventilation while maintaining a comfortable temperature, consider:</p> <ul style="list-style-type: none"> • opening high level windows in colder weather in preference to low level to reduce draughts • increasing the ventilation while spaces are unoccupied (for example, between classes, during break and lunch, when a room is unused) • providing flexibility to allow additional, suitable indoor clothing • rearranging furniture where possible to avoid direct draughts
